This is to draw the attention of all candidates who had indicated YES to the PwBD category in the application portal and requested for **special assistance** in ISI admission test 2026.

Based on your application, relevant certificates submitted, facilities asked for and suggestions from our institute doctor, we have prepared a list of the facilities we will provide to the candidates mentioned below. You can identify yourself from your application number and registration number.

The arrangements for Persons with Disabilities in the admission tests of ISI, and criteria used for the same, will be in accordance with the Guidelines for conducting written examinations for Persons with Benchmark Disabilities, as per Office Memorandum F. No. 34-02/2015-DD-III dated 29<sup>th</sup> August, 2018 of the Ministry of Social Justice and Empowerment, Government of India. A brief indication is given below.

The services of a scribe are available to candidates as per the above indicated Office Memorandum (Para VI, Page 2 and Para XII, Page 3).

- (i) An eligible candidate will arrange for own scribe and the qualification of the scribe will be one step below the qualification of the candidate taking the examination. The candidate with benchmark disabilities opting for own scribe should submit details of the own scribe as per proforma at Appendix-II of the attached Office Memorandum [F. No. 34-02/2015-DD-III](#) dated 29<sup>th</sup> August, 2018 along with copy of photo identity card (Aadhar/ Voter Id / PAN /Passport / Driving License) and certificate of qualification of the scribe, by e-mailing at [admissionsupport@isical.ac.in](mailto:admissionsupport@isical.ac.in).
- (ii) A candidate who has been allowed scribe would get 20 minutes compensatory time per hour of examination, i.e., 40 minutes extra for the two hour examination in both the forenoon and afternoon sessions.

If it is found that a candidate has used the services of a scribe and/or extra time, but DOES NOT possess the extent of disability that warrants the use of a scribe and/or extra time, he/she will be excluded from the process of evaluation, ranking and admission. If the candidate has already been admitted, his/her admission will be cancelled.

#### General Information

1. The Institute will not provide scribes to candidates who are eligible for the same.
